What information do we want to collect about you?

- The information that we want to collect about you is your name, address, email and contact details, alongside the areas of breeding, exhibiting, showing, judging, managing cats/and or cat shows for the Governing Council of the Cat Fancy.
- Additionally we will require two references who can avouch for your character and standing within the community (this may not be friends or relatives).
- We will also require an up-to-date photograph of you, (this may be in electronic or physical format).
- You will also be required to sign the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 (as amended in 2013).

How will we use the information about you?

- The information you provide on this form will be used by the Administrators to verify your standing within the community and any relative experience you have with children.
- Your References will be checked and they will taken into account along with the reason why you have applied for this position to assess your suitability.
- Your name and the areas in which you have indicated that you are willing to/and can assist Candidates with their coursework will appear in a spreadsheet (similar to those used by Show Managers when choosing judges for their shows) alongside your photograph.

Information Storage

• Your form will not be stored electronically or on a database.
