### PARENTAL/PHOTOGRAPHIC CONSENT FORM

Please read this form carefully – it is a parental photographic consent form for participation in the GCCF's YES! Scheme ("the Scheme"). This Scheme is organised by/on behalf of the Governing Council of the Cat Fancy ("the GCCF"), with assistance from affiliated clubs, judges, stewards, show managers, and other persons acting on their behalf ("the Scheme Organisers").

No person under the age of 16 may be accepted into the Scheme unless this form has been read and signed by that person's parent or legal guardian.

### Part 1 – Risk factors

Some of the potential risks of photography and filming at events include:

- 1.1 Children may be identifiable when a photograph is shared with personal information.
- 1.2 Direct and indirect risks to children and young people when photographs are shared on websites and in publications with personal information.
- 1.3 Inappropriate photographs or recorded images of children.
- 1.4 Inappropriate use, adaptation or copying of images.

#### Part 2 – Usage of Images

YES! have our own team of YES! approved photographers. The Photographers are also Mentors on the scheme, and will have had their references the supplied when they joined the scheme checked. Additionally their photograph/s appear for identification purposes inside the NOVICE section of the YES! website where they will be accessible to all participants on the Scheme. At GCCF shows, our photographers will wear clear badges stating their name and affiliation to the Scheme.

2.1 By signing this form you are agreeing to allow YES! approved photographers to take photographs of your child either when:

- 2.1.1. The Candidate is Second Stewarding for a judge.
- 2.1.2 The Candidate is working on the table alongside the Show Manager.
- 2.1.3 The Candidate is distributing rosettes or prize cards at a show.
- 2.1.4 The Candidate during her Presentation to a judge.
- 2.1.5 Share images of the Candidate on the Secret YES! Facebook page, or in the Candidates area of the YES! website to show participation and for encouragement and appreciation.
- 2.2 What a YES! Photographer will NOT do is:
  - 2.2.1 Take an inappropriate photographs of your child.
  - 2.2.2 Take photos of your child when they are not actively engaged in working on the Scheme at a show.
  - 2.2.3 Take any photos of your child when they are not at a show.
  - 2.2.4 Share any photographs/images of your child with anyone either in print format or on social media without your explicit prior written consent.
  - 2.2.5 Share any photo of your child which includes their full name and location.
